



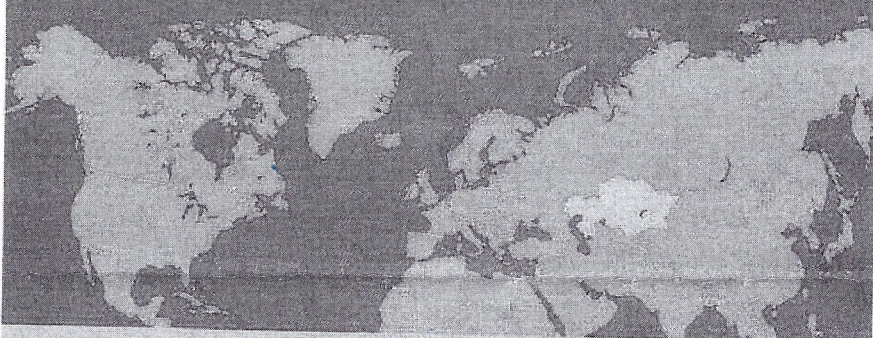
NEW ELECTRONIC VISA TO KAZAKHSTAN

Kazakhstan is introducing a new electronic format process for foreign citizens to receive a single entry visa.

Tourist electronic visas are issued to citizens of 117 countries, while business and medical treatment visas to 23 states. The full list of countries is available on the web-site www.vmp.gov.kz/en

An invitation from the Kazakh side is required to apply for the visa.

Foreigners can enter/exit Kazakhstan using a valid electronic visa only at the international airports in Astana and Almaty.



STEP BY STEP GUIDING TO OBTAINING THE E-VISA

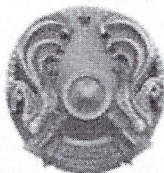
-  1. Register on the website of the Visa and Migration Portal (www.vmp.gov.kz/en)
-  2. Familiarise with the requirements for obtaining the e-visa
-  3. Enter the invitation number (sent by the inviting side in Kazakhstan) and fill in the visa application form
-  4. Pay the consular fee
-  5. Print the e-visa, which will be available in the user's personal cabinet on the website, as well as sent to the email address provided
-  6. Present the printed e-visa at passport control at the international airports in Astana or Almaty

VISA-FREE REGIME

Note.

1. This E-VISA print must be declared to the authorities of The Republic of Kazakhstan during border passport control.
2. E-VISA gives you right to enter/exit The Republic of Kazakhstan only in Astana and Almaty International Airports.
3. This E-VISA print must be held with passport during the stay in The Republic of Kazakhstan.

Памятка.

3. Распечатка E-VISA должна храниться с паспортом во время всего пребывания в Республике Казахстан.



Information about e-visa of the Republic of Kazakhstan

The Republic of Kazakhstan is introducing a procedure for obtaining **a single entry visa for foreigners in electronic format** from January 1, 2019.

An **electronic visa** (*business, tourist and medical treatment*) is issued based on a valid invitation from the Kazakh side, considered by the migration service units of the Ministry of Interior of the Republic of Kazakhstan under the established procedure.

Foreigners can enter/exit the territory of the Republic of Kazakhstan using a valid electronic visa **only through the checkpoints of international airports of Astana and Almaty**.

Tourist electronic visas are issued to citizens of 117 states, business and medical treatment visas - 23 states (the list of countries is attached).

The electronic visa is valid only for the recipient of the visa and does not apply to accompanying persons.

Paid consular fees are not refundable.

Passport provided by the recipient of a visa should meet the following criteria:

1) should not cause doubts in authenticity and belonging to its owner, have marks of extension, reservations, notes, erasures and corrections, torn or unsewn pages;

2) should have at least 2 blank pages;

3) should expire no earlier than 3 months from the expiry date of the requested visa.

The Kazakh inviting side informs the migration authorities about arrived foreigners within three working days (this service is available online at the Visa and Migration Portal).

Step-by-step e-visa issuance algorithm

- in order to obtain an electronic visa, you should register on the website of the Visa and Migration Portal (www.vmp.kz);
- after registration, learn about the requirements for obtaining an electronic visa;
- enter the invitation number (*sent by the inviting side in the Republic of Kazakhstan*) and fill in the visa application form;
- pay the consular fee;
- print an electronic visa (*the visa is formed in the personal cabinet as well as sent to the email address you provided when filling in the registration form*);
- present a printed electronic visa when passing through passport control at international airports in Astana and Almaty.
